"A nearby vacant lot (2.3 acres) is for sale on Zillow for \$200 million," John LeFevre, a former investment banker who created the Goldman Sachs Elevator social media account, wrote alongside a screengrab of the listing. "Mar-a-Lago sits on 17 acres, with waterfront on both sides." He added: "The primary point is this: The lending bank is required to get a valuation from a third party to cover its LTV calculation. No one had an issue with any of this. Everyone made money...Until an activist [District Attorney] came along decades later," a reference to Letitia James, who brought the case. Ali Zein Yousuf, a software engineer, replied: "You're right, if it was priced at the

same per acre as the empty lot, it'd be [\$]1.5 billion." There are competing estimates as to the size of the estate; several publications have

said it spans 17 acres, while the club's website says it is 20 acres. According to the asking price of the empty lot listing, this would in


