Re: Update to Your California Public Records Act Request No. 24-365

Dear Diana Falzone:

The City of Monterey provides this updated response to your California Public Records Act request for any police report involving Peter Hegseth (aka Pete Hegseth).

Upon further investigation by the Monterey Police Department (MPD), its records indicate a redacted version of Monterey Police Report YG1705129 was released to Mr. Hegseth on March 30, 2021, pursuant to his request. Therefore, the exemptions claimed in the City's prior response to your request are not applicable. (See, *Berkeley Police Ass'n v. City of Berkeley* (1977) 76 Cal.App.3d 931, 941-42; *Kinney v. City of Corona* (2023) 99 Cal. App. 5th 1, 9, *quoting County of Santa Clara v. Superior Court* (2009) 170 Cal.App.4th 1301, 1321-1322.) As such, Monterey Police Department Report YG1705129 is enclosed with redactions to ensure the confidentiality of the victim's identity and that of her minor children. The identities of victims of certain types of crimes, including victims of sexual assault, are required to be withheld if requested by the victim. (Government Code section 7923.615, subd. (b).) Also, the public interest in the identity of the victim and the names of and information regarding her children is not outweighed by their right to privacy. (Government Code section 7927.410, subd. (d).)

Please note, however, that another agency's Police Report, Kaiser Permanente Report, an audio recording, surveillance footage, a photograph, and memorandum from the Monterey County District Attorney's Office, that are responsive to your request, were never released and remain confidential. These files are exempt from the California Public Records Act pursuant to Government Code sections 7923.600, 7923.605, and 7927.705, and California Penal Code section 11163.2.

I am the official responsible for making the determinations regarding your request pursuant to Government Code section 7922.540(b). Please feel free to contact me should you have any questions.

The patient was allegedly sexually assaulted at the Hyatt Hotel between 10 10-7-17 and 10-8-17. 11 12 13 I recommend this case be forwarded to investigations for their review. 14 15 INVESTIGATION: 16 On 10-12-17, at approximately 1223 hours, I received a telephone detail from 17 Nurse at Kaiser Permanente in 18 19 20 informed me that a patient had come into their center requesting a sexual assault examination. said the patient wished to be identified 21 22 as JANE DOE. said that DOE was in Monterey between 10-7-17 and 10-8-17, staying at One Old Golf Course Road the Hyatt Hotel for business. 23 said that at some point late at night on 10-7-17 or early morning on 24 25 10-8-17 DOE was at the Hyatt consuming alcohol with coworkers. 26 said DOE was not sure, but believes that something may have been slipped into her drink, as she cannot remember most of the night's events. 27 28 that DOE remembers being in one of her coworker's hotel rooms and remembers 29 being ejaculated on. said DOE could not remember whether or not 30 any sexual penetration occurred, but believes that she was sexually assaulted at 31 that time. 32 33 said that DOE had then returned to her home in 34 had come in to Kaiser Permanente on 10-12-17 to request a sexual assault 35 said that she was reporting this incident, as she was a exam. 36 mandated reporter. said that she was going to refer DOE to an emergency hospital room for an examination. DOE had been drinking and the events were blurred and lacked specifics and a fluid sequence of events. DOE remembers HEGSETH preventing her from leaving and somehow ended up on top of her. DOE remembers HEGSETH ejaculating on her stomach. DOE does not remember what happened after that other than she ended up back in her hotel room. SART NURSE conducted the SART exam and collected the dress and panties from the night of this incident.

The incident was originally reported to the Police Department. 18 The incident had occurred sometime between 10-7-17 to 10-08-17. JANE DOE 19 Police Department case 20 named the suspect as PETER HEGSETH. The 21 number was 22 23 I contacted Police Department, via telephone and requested a copy of their report. I was advised by the Records staff that the report was not 24 25 completed. 26 27 On 10-13-17, a case report request was faxed to Police Department. 28 29 I responded to the hotel and contacted the front office manager 30 . I referenced JANE DOE and HEGSETH'S name. I asked 31 to provide me with a print out for JANE DOE and HEGSETH'S 32 room receipts. provided me with a copy of the room receipts. 33 34 HEGSETH was in room #528. He checked in on 10-7-17 and checked out on 10-35 8-17. 36 37 JANE DOE was in room She checked in on 7 and checked out on 38 17. 39 For further information regarding the hotel receipts, refer to the attached copies. 40 41 I inquired about the hotel's video surveillance. 42 advised me that the 43 business has video surveillance video, but I would have to contact was not currently available. 44 45

73	DOE stated she had to go to the after party at the President's suite. The

76	JANE DOE stated she had consumed a small amount of champagne at the after
77	party. JANE DOE does not remember drinking hard alcohol. JANE DOE stated
78	HEGSETH was at the after party. Several people had attended the after party
79	and people were coming and going from suite to suite. JANE DOE stated most of
80	the members wanted to talk with her because she was an advocate and was very
81	busy talking with members of the federation.

83	JANE DOE stated she remembered going to Knuckles Sports bar. Knuckles
84	Sports bar is a bar that is attached to the hotel. JANE DOE stated she was with a
85	group of women when she attended the bar. JANE DOE stated "that's when
86	things got fuzzy." JANE DOE remembered being at the bar with
87	and ANE DOE
88	remembered being handed one drink by the bartender, but does not remember
89	how many alcoholic beverages she had.

JANE DOE stated during the evening she was in contact with were, via text messages. The text messages between JANE DOE and were exchanged throughout the night. JANE DOE stated she had consumed "much more than normal" alcoholic beverages, throughout the day.

JANE DOE stated she observed HEGSETH acting inappropriately with the woman at the conference. HEGSETH would rub the women on their legs and JANE DOE thought that his actions were inappropriate. JANE DOE had texted that HEGSETH was giving off a "creeper" vibe. The women thought HEGSETH was "dreamy" and wanted pictures with HEGSETH. JANE DOE stated she had also taken a picture with HEGSETH, earlier in the day because people were commenting HEGSETH.

JANE DOE stated she remembered walking out of the bar and assumed HEGSETH followed her because she argued with HEGSETH near the pool. The argument was about HEGSETH'S actions with the women at the conference. JANE DOE remembered HEGSETH tell her that he was a nice guy.

 JANE DOE stated the next memory she had was when she was in an unknown room. JANE DOE did not know where she was and how she got to the room. HEGSETH was in the room with her. JANE DOE remembered having her phone and HEGSETH inquired to whom JANE DOE was texting. HEGSETH took her phone from her hands. JANE DOE stated she got up and tried to leave the room, but HEGSETH blocked the door with his body. JANE DOE remembered saying "no" a lot. JANE DOE stated she did not remember much else.

JANE DOE'S next memory was when she was on a bed or a couch and HEGSETH was over her. HEGSETH'S dog tags were hovering over her face. HEGSETH was bare-chested, but JANE DOE does not know if his shirt was completely off. JANE DOE did not notice any tattoos, scars and or marks on HEGSETH'S body. JANE DOE stated she had seen HEGSETH fully nude during this incident.

The next memory JANE DOE had was when HEGSETH ejaculated on her stomach. HEGSETH threw a towel at her and asked her "are you ok?"

The last memory JANE DOE remembered was walking into her room and getting into bed with JANE DOE stated she does not remember how she got back to her room.

JANE DOE stated she woke up in the morning and took a shower before going to work. The incident involving HEGSETH did not dawn on JANE DOE, until she was home, on Monday.

136 Monday, JANE DOE had sex with . The sexual encounter with triggered her memory of the incident with HEGSETH. JANE DOE stated she 137 used a condom when she had sex with 138 because 139 140 Approximately four days later, on Thursday night, JANE DOE went to the hospital 141 142 because she believed she was sexually assaulted by HEGSETH. During the last few days before going to the hospital, JANE DOE stated she showered daily. 143 144 JANE DOE stated she had a vaginal discharge and was diagnosed with bacterial vaginosis (BV). Based on my training, I know that BV can be caused by having 145 multiple sex partners or having a new sex partner. There are other factors that 146 cause BV, but are not limited to sexually transmitted diseases and douching. 147 148 JANE DOE stated she does not douche. 149 While at the hospital, JANE DOE had given the clothes she wore on 10-7-17, to 150 Police Department. The clothes were not washed prior to having been 151 given to the Police Department. A SART exam was conducted at the 152 153 hospital. 154 155 I asked JANE DOE if she had a copy of the photo she took with HEGSETH. JANE DOE advised me that she had the copy and would forward it to me. 156 157 158 I asked JANE DOE if she had the text messages between herself and JANE DOE advised me that she had the text messages and would send me 159 160 screen shots of the messages. 161 162 I advised JANE DOE of victim's rights, per 293 PC. JANE DOE elected to keep her name confidential and advised that it was ok for me to write her name in the 163 signature box. 164 165 166 I later send JANE DOE my business card, case report number and a Marsy's 167 card, via U.S. mail. 168 I received the messages and picture, via email. 169 170 The picture showed JANE DOE wearing 171 172 173 174 175 176

HEGSETH and JANE DOE are seen walking out of the lobby, still locked arms and headed towards the pool. Part 327 of the group was , JANE DOE and HEGSETH. stated JANE and HEGSETH were in their own group of conversation, while at 328 DOE. 329 Knuckles Bar. witnessed JANE DOE and flirt with HEGSETH. There was also mention of 412 HEGSETH placing his hand on knee. 413 On 10-26-17, I had contact with HEGSETH, via telephone. HEGSETH provided 414 415 me with the following information: 416 417 HEGSETH was a key note speaker at the on 10-7-17. The conference/ fund raiser was held at the Hyatt Regency 418 Spa and Hotel.
